4. Photographs should be at least 5 x 7" and no larger than 8 x 10" in size. **Photos cannot be in frames and must meet the size requirements.** Photos will be placed in sheet protectors at time of entry. Photos will be available for pick up at the Fulton County Fair Beauty Revue.
5. **NEW Rule - There is a \$5.00 entry fee for each photo if entered by July 15, 2010. Entries received after July 15 will be charged a \$10.00 fee. No entries will be accepted after July 30, 2010.**
6. Entry deadline is **July 30, 2009. but contestants are encouraged to take advantage of the July 15th entry date and get a discount on the entry fee. No entries will be accepted after July 30th ..**
